1. BACKGROUND

Pawan Hans Ltd. a Public Sector Enterprise under Govt. of India was established in year 1985 and is one of the largest helicopter operators in South East Asia. The Company operates a mix fleet of 43 helicopters providing its services in the areas of Oil & Gas, Passenger services, Inter-island connectivity, Law & Order, Charters, VIP Flying and other specialized services.

2. FLEET DETAILS

Company operates a mix fleet of 43 helicopters consisting following type of helicopters :

3. REQUIREMENT

To meet growing demand of helicopters from its customers, Company intends to engage agency/ Operators/ Firms to provide experienced and qualified Pilots (On type qualified PIC). PHL is in the process of acquiring additional type of helicopters in its fleet e.g. Sikorsky S-76D.PHL shall entrust empanelled agencies/ operators/ firms to provide On-Type qualified Helicopters Pilots and AMEs to fly helicopters owned by company as well future acquisition as decided from time to time.

4. QUALIFICATION CRITERIA

i) Eligibility Criteria

- Bidders should a registered Aviation Agency/Firm/ Helicopter Operator currently in the Business of Aviation.
- Bidders should have atleast 5 years experience in the field of Aviation business.
- Bidder should have positive net-worth for last 3 financial years i.e. FY 2019-20, 2018-19, 2017-18 and should not be less than 60% of average Annual Turnover.

- Bidder should have Annual Turnover of minimum One crore in INR for the last 3 consecutive financial years.
- Company should have registered/ representative office in India. In case, no office is available in India, select Bidder is required to setup the office in India within one month of award of LOA by PHL.

iii) Consortium of Consultants-:

Professional consultant agencies may associate with each other to form a consortium to complement their respective areas of expertise, or for other reasons. Such an association may be for the long term (independent of any particular assignment) or for a specific assignment. The consortium may take the form of a joint venture or of a sub consultancy. In case of a joint venture, all members of the joint venture shall sign the contract and shall be jointly and severally liable for the entire assignment. Consortium shall be formed before submission of EOI.

- 5. The **Terms of Reference (TOR)** of the selected Agency/ Firm/ Operator would be as under:
 - Providing Helicopter Pilots (On type qualified PIC) and AMEs as per experience and qualification criteria provided by Pawan Hans to meet mission requirement of PHL Customers in the areas of Off-shore as well as On-shore.
 - Conducting all Training, Prof Check, Medical and other requirements from time to time in adherence to DGCA, India guidelines.
 - Providing replacement Pilots/AMEs at its own cost in case of non-availability of offered Pilots/AMEs due to Health Emergency and other reasons.
 - > Pilots and AMEs to be offered at PHL Locations as per flying schedule provided.
 - Lodging, Boarding and transportation to be arranged by selected Agency/ Firm/ Operator at its own cost, including International Travel, if any.
 - > Insurance of Crew as per DGCA India, regulations.
 - > Meeting DGCA CAR in respect to flying and Maintenance of Helicopter Pilots in India.
 - PHL will liaise with local office of selected Agency/ Firm/ Operator for all matters related to offered Pilots and AMEs, including billing matters.
